Shredding plants for process-safe processing

In connection with plant components such as lifting and tilting devices, screw conveyors, scrubbers, separating techniques as well as suction and filter systems, ERDWICH also supplies customer-specific and turnkey plants.

Plant examples:

- Large-scale plant for crushing the contents of 1.1 cbm containers, mobile. Outdoor installation
- Shredding plant installed over 2 building floors
- Large shredder for crushing whole cardboard drums with contents
- Crushing plant with press container
- System with movable shredder and 3 press containers
- System with manual feeding and discharge into 1.1 cbm container
- System with three-shaft shredder for dust-tight operation

Crushing and dewatering plants for infusion bottles and related equipment:

- Crushing plant with drainage channel and discharge belt
- Multifunctional shredder for shredding infusion bottles (wet), alternatively blister packs (dry)
- Shredding plant with discharge via screw with integrated flushing device
- Shredder plant with dewatering screw and lifting and tipping device
